- 1. Public Forum: Each senior spoke about their plans after graduation
- 2. Mr. Lane gave his report on the elementary and district. Mr. Stickles gave his report on the high school. He reviewed the results from BETA. Nationals will be in Louisville, KY. The road closing between the school and the Gym is waiting on one more signature at the county. He spoke about an Extended/TEA Nursing Grant August 31<sup>st</sup>.
